GARAGE TO GARAGE BILLING: This is the method used to determine the amount of time that it takes to get to/from the base of operations. The minimum travel time applied each way is 30 minutes & is **ALREADY INCLUDED** in the confirmation estimate.

TIP: Any tips are completely passed through to the driving staff and appear in the Extra Gratuity section of the bill. Client and Guest are expressly informed that the payment of a tip is optional and may be increased or decreased at their discretion **BUT** whether a tip is to be given, and its amount, are matters determined solely by the customer and the customer has discretion to pay whatever amount the customer deems appropriate, if any, based on the quality of service provided. A modest Service Fee may also have been added for convenience and may be passed in part or in full to the driving staff but service fees are not tips.

TERMS AND CONDITIONS

These terms and conditions are to the Agreement between the passenger, the credit card holder and/or the person ordering, each of whom is or may be named on the reservation form, (collectively "Customer"), and American Executive Sedan Services, Inc. (AES) The Agreement, when executed and received by AES, supersedes all other agreements or understanding, either verbal or in writing, and is valid for all reservations for future. Customer represents to be at least 18 years of age and legally capable of entering into this contract under the Commonwealth of Virginia Law.

Payments:

- Payment information must be supplied at the time of booking.
- Minimum booking for Sedan is 1 hour, SUV is 2 hours, Mini-Bus is 4 hours.
- The contract price establishes estimated costs only and is subject to change. (Wait time on transfers will be applied in 15 minute increments after a grace period of 15 free minutes. If the trip runs over the scheduled time, overages will be applied based on the hourly rate in 15 minute increments, with the exception of the Coach Bus, which is charged

in 1 hour increments).

- No refunds will be issued if the Customer uses less time than the time reserved.
- If Customer wants the chauffeur to use a toll road, toll fees will be added to the charges.
- If Customer pays by Credit Card, Customer authorizes AES to charge all amounts owed under this Agreement to the Credit Card number provided by customer on the reservation sheet with no further signatures or documentation required. Your execution of this agreement binds you as a credit card holder as if you signed the actual credit card receipt.

Cancellations:

- A service fee equal to the total trip cost will be charged for cancellations made less than 2 hrs for Sedans and SUVs, 24 hrs for premium Sedans, Limousines, 48 hrs for Vans & Mini Buses, & 72 hrs for Coach Buses prior to the scheduled pick up time.
- All reservations booked for 3 hrs or greater require 50% deposit at time of booking which is non-refundable 48 hours prior to contract start time unless otherwise specified.
- AES will not be responsible for delays due to traffic conditions, accidents, or any other causes beyond its control.

- Any unusual spill, soiling or damage to the vehicle caused by the passenger/passenger's guests will result in a minimum of \$250 clean-up-fee charged directly to the credit card on file.
- Vehicles cannot be loaded beyond seating capacities.
- No alcohol permitted in the vehicle if any minor (under 21 years of age) is present.
- AES representative/chauffeur reserves the right to refuse service to any passenger for any type of gross misconduct or inebriation.
- AES is not responsible for items left in vehicles.
- AES will not be responsible for delays due to traffic conditions, accidents, or any other causes beyond its control.
